## Northern Ireland Peatland Strategy 2021-2040.

In 1993, the Department of Environment, supported by the Council for Nature Conservation and the Countryside (CNCC), published "Conserving Peatland in Northern Ireland – A Statement of Policy", which set out the Government's policies for protecting and conserving peatland.

However, since then, much has changed in the appreciation of our peatland habitats and a greater acknowledgement of the role their play in Climate Change mitigation and the Ecosystem Services they provide.

The UK Peatland Strategy was published in 2018 and identifies a common way forward and sets the context for the devolved administrations strategic peatland action plans. It is under the auspices of the UK Peatland Strategy that we propose to take forward a Peatland Strategy for Northern Ireland. Our Strategy will set the direction of travel over the next 2 decades and beyond and provides a framework for both conserving intact peatlands and a peatland restoration programme.

The Draft Northern Ireland Peatland Strategy Consultation Document provides information on a series of Strategic Objectives and Actions that the Department and its partner organisations intend to take forward. We welcome your views and consultation responses will be used to inform the Northern Ireland Peatland Strategy and the accompanying Implementation Plan.

Section 75 of the Northern Ireland Act 1998 places a duty on public authorities to have due regard to promote quality of opportunity. The Department has completed an initial Equality Impact Assessment screening exercise in order to ascertain if the proposed Northern Ireland Peatland Strategy will have an impact on the Section 75 groups and has concluded that no adverse differential impact is likely. Therefore, the Department does not consider a full Equality Impact Assessment to be necessary.

Rural proofing is a process to ensure that all relevant Government policies are examined to assess whether or not they have a different impact in rural areas. It is considered that there are no negative impacts on rural productivity or the provision of services to the rural community as a result of these proposals.

The Human Rights Act 1998 implements the European Convention on Human Rights. The 1998 Act makes it unlawful for any public authority to act in a way that is incompatible with these rights. The Department considers that the proposals detailed in this consultation paper are compatible with the Human Rights Act 1998.

A Habitat Regulations Assessment screening exercise was conducted to establish the likely impact of the Northern Ireland Peatland Strategy on Northern Ireland's Natura 2000 sites. The findings of this screening exercise indicate that the actions proposed for the inclusion in the Northern Ireland Peatland Strategy are unlikely to have any significant, detrimental effects (either alone or in combination with other plans or projects) on Natura 2000 sites.
