The Northern Ireland Peatland Strategy, under the auspices of the UK Peatland Strategy, will provide a framework for both conserving our intact peatlands and our peatland restoration programme. The aim of this Strategy is to ensure that by 2040, all peatlands in Northern Ireland are conserved or restored to healthy, functioning ecosystems and that the ecosystem services that they provide are acknowledged and appreciated. The scope of this strategy includes peatland with semi-natural vegetation and peat soils that can be restored to peatland with semi-natural vegetation, whether publicly or privately owned.

Semi-natural peatland habitats are found across Northern Ireland, although Blanket Bogs tend to have a largely northern and western distribution. They are not found in urban areas by definition. The draft Northern Ireland Peatland Strategy will provide a framework to guide both the conservation and restoration of semi-natural peatlands in Northern Ireland. As peatlands are not found in urban areas, it is expected that the Strategy will be of interest to a greater proportion of the population who live in rural rather than urban areas. That being said however, peatlands in good condition are a nature-based solution to climate change and as such will be of interest to the entire population of Northern Ireland.

on people in rural areas differently.
A number of actions contained within the draft Peatland Strategy involve possible updates to legislation and polices around peatland conservation and restoration that may have a greater impact on population who live in rural as opposed to urban areas e.g. policies around commercial peat extraction and the exercise of Turbary Rights, agricultural and land use policies and the potential for designation of ASSIs. There are also actions in the draft Peatland Strategy which refer to the need for the development of bespoke training courses to build capacity and practical skills for those involved in peatland conservation and restoration. This may lead to enhanced job opportunities in rural areas.
