## Consultation on Northern Ireland Peatland Strategy Equality Impact Assessment

I am writing to invite you to share your views on the Northern Ireland Peatland Strategy Equality Impact Assessment.

## **Background**

The UK Peatland Strategy was published in 2018 and sets the context for the devolved administrations strategic peatland action plans. A public consultation exercise on a draft Northern Ireland Peatland Strategy was carried out in 2021 and in light of the comments received, DAERA has produced the revised Northern Ireland Peatland Strategy document, which details the Strategic Objectives and associated actions that the Department and its partner organisations intend to take forward. The Department has also carried out an **Equality Impact Assessment** on the revised strategy.

We welcome your views on the Equality Impact Assessment and consultation responses will be used to inform the final Northern Ireland Peatland Strategy document.

## Consultation

The consultation will run for a **12 week period** from **12<sup>th</sup> August 2022**; the deadline for responses to is **23.59 4<sup>th</sup> November 2022**. All responses should be received by then to ensure they can be fully considered.
